#### OUR EVENTS

Angelstone Events is proud to host another season of first-class equestrian competition at Caledon Equestrian Park and Angelstone. This year, we will be offering 10 major events at the Caledon Equestrian Park and 6 Major events at Angelstone. We will also be hosting dressage events at both parks - dates TBA.

With the consideration of additional programs, we are continuing to grow our demographic which includes men and women, of all ages. The addition of the Equine Choice Silver Series will bring over 1000 new athletes to both parks on a weekly basis.

#### YOUR OPPORTUNITY

Vendors of these growing events will reach a captive audience of equestrians and their families, an audience that will reach many people throughout the competition season. Attendees and riders typically come from across the country to attend our scheduled events.

#### THE RETURN

Becoming a vendor at any of the 2023 events provides your business with unique access to a motivated and committed audience. By supporting the equestrian community, you are addressing the venue's attendees directly who care deeply about the tradition and future growth of their sport.

Our events will take place on-site at Caledon Equestrian Park and Angelstone in Erin, and include a minimum of 3 competition rings at each event (with the exception of the Dressage events). Event vendors will be located outdoors along the west side of the indoor arena wall, or in the central vendor area at the Park. Vendors at Angelstone will be located in the designated Vendor area, central on the property.

Benefits and recognition include your exhibit vehicle and web links on our official event website. We have designed our vendor package to maximize your organization's visibility and expand your client base. Vendors may also choose to become a sponsor of our events and/or advertise in souvenir programs where offered.

#### YOUR VENDOR SPACE INCLUDES:

- 10' x 20' allocated space (Suitable for a self-contained mobile unit)
- Basic electrical (15 amp)
- Wireless Internet is available on site for phone/POS terminals.
- A vendor list will be populated and placed on the Caledon Equestrian Park and Angelstone social media (or websites) advertising your presence for the reserved event.

## YOUR COMMITMENT

Tentative Schedule:

- Vendors of Hunter/Jumper and Dressage competitions are required to be open for business Friday, Saturday & Sunday, 10 am - 3 pm (unless the competition day ends before 3 pm). Vendors can be open for each day of competition, 8 am until close if preferred, but are required to operate within the above-noted parameters.
- Vendors of Angelstone during Major League Show Jumping in August and The Caledon Cup at CEP in September are required to be open for business each Saturday night until 7 pm, although you may choose to remain open longer.

## INSURANCE REQUIREMENTS

The Vendor shall, at its sole expense and cost, carry (i) a policy of general liability insurance against claims of personal injuries, wrongful death, or property damage occurring on or about Angelstone Events with a minimum amount of two million dollars (\$2,000,000). A Certificate of insurance (COI) verifying said policy and naming Angelstone Events., Caledon Equestrian Park, Angelstone Farms, Town of Caledon, and Toronto and Region Conservation Authority (TRCA) as additional insureds must be provided to Angelstone at the time of application.

# VENDOR RENTAL AGREEMENT

**UPON RECEIPT, THIS VENDOR AGREEMENT CONSTITUTES A VALID AND BINDING CONTRACT**

**Central Venue Name:** Caledon Equestrian Park  
**Location:** 200 Pine Ave, Caledon, ON L7E 0M1

**West Venue Name:** Angelstone Tournaments  
**Location:** 8720 Wellington Road 50, Erin, ON N0B 2K0

**Date(s):** To cover any requested event dates, May 2023 – October 2023

**Set Up for Hunter/Jumper & Dressage Competitions:** Event vendors may arrive on the Monday before the requested event date to set up and will be ready for direct sales by the first active day of competition.

**Placement:** The placement of all vendors will be determined by Angelstone Events. Vendors may not assign or sublet any portion of the assigned vendor space, or have representatives, equipment, and/or materials from any firm other than its own in the vendor area.

**Right of Refusal:** Angelstone Events reserves the right to review and reject any application for vendor space without prejudice. Angelstone reserves the right to terminate the Vendor Rental Agreement providing the event vendor is in breach of contract.

**Security:** Security will not be provided at any time. Angelstone Events, Caledon Equestrian Park, Angelstone Farms, Town of Caledon, and/or TRCA are not responsible for theft or damage of property or product.

**Cancellation:** Written cancellation is required a minimum of 30 days prior to the requested event to receive a full refund of applicable vendor fees. If cancellation occurs within 30 days of the requested event, 50% of applicable vendor fees will be refunded.

**THIS CONTRACT** is executed by the undersigned vendor for the benefit of Angelstone Events (ASE). A company whose prime objective is to manage events at Caledon Equestrian Park and Angelstone. The vendor is requesting participation in select events being offered at Caledon Equestrian Park and Angelstone by Angelstone Events during the 2023 season. The vendor hereby agrees as follows:

## **VENDOR RESPONSABILITIES:**

In connection with the execution of this contract, the vendor shall:

1. Provide their own fully self-contained mobile unit or tent (tents are not recommended due to inclement weather possibilities).
2. Undertake to observe all rules and directions which are imposed by Angelstone Events(ASE) and Caledon Equestrian Park / Angelstone generally or specifically in respect of the space which is being used.
3. Vendors are **required** to be open for business within the parameters previously stated.
4. Provide at its own expense the necessary safeguards to protect the Vendor's property where left overnight in the facility.
5. The signage should be professional in appearance. There are no walls around your space to hang or lean merchandise on.
6. No use of the Caledon Equestrian Park or Angelstone logo is permitted without the prior consent of either party in writing.

**INSURANCE REQUIREMENTS:** The Vendor shall, at its sole expense and cost, carry (i) a policy of general liability insurance against claims of personal injuries, wrongful death, or property damage occurring on or about Caledon Equestrian Park or Angelstone Farms with a minimum amount of two million dollars (\$2,000,000). A Certificate of insurance (COI) verifying said policy and naming Angelstone Events, Caledon Equestrian Park, Angelstone Farms, Town of Caledon, and Toronto and Region Conservation Authority

(TRCA) as additional insureds must be provided to ASE at the time of application.

**RELEASE AND INDEMNIFICATION:** In consideration of the vendor's acceptance to participate in the Event, the Vendor hereby voluntarily assumes responsibility for, and releases, waives, acquits, and forever discharges Angelstone Events, Caledon Equestrian Park, Angelstone Farms, The Town of Caledon and Toronto and Region Conservation Authority (TRCA) along with their respective boards of directors, officers, agents, employees, members, sponsors, contributors, exhibitors and volunteers (collectively, the "Releasees"), of and from, and agrees legal action cannot be perused on account of, any and all liability, demands, losses, claims, and damages of every kind whether now or hereafter existing, arising out of, or in any way connected, directly or indirectly, with the event or vendors participation in the event, whether arising out of, attributed to or caused or alleged to have been caused by the negligence (sole, joint, concurrent, active, or passive), gross negligence, or intentional conduct of any of the releases.

Vendor further agrees to indemnify, defend, and hold harmless the Releasees from and against any and all claims, demands, losses, liabilities, damages, costs, and expenses, including but not limited to reasonable attorney fees, for injury, death, loss, or damage of whatever nature to any person, property, or any claim resulting from, arising out of, or in any way related to (i)Vendors use and occupancy of the premises, (ii) Vendors participation in the event, or (iii) any act or omission of Vendor, its agents, employees, or independent contractors or anyone directly or indirectly employed by any of them, or anyone for whose acts or omissions any of them may be liable, whether arising out of, attributed to or caused or alleged to have been caused by the negligence (sole, joint, concurrent, active, or passive), gross negligence, or intentional conduct of any of the Releasees.

In executing this contract, the Vendor acknowledges and represents that the Vendor has read the forgoing contract and will be bound by its contents.
